

## ANNOUNCEMENT REGARDING PAYMENT CARDS ISSUED BY ING BANK

### Limits for Payment Transactions

#### Debit Cards, Company Pre-paid Cards and Individual Payments Identification Cards

1. Daily Limit for Cashless Transactions – a determined by ING Bank and the Customer maximum daily amount of Cashless Payment Transactions in PLN, inclusive of a daily limit for:
  - a. Distance transactions – Distance Cashless Payment Transaction of the following type: telephone order, mail order, order via Internet. The limit for distance transactions cannot be higher than Daily Limit for Cashless Transactions.
  - b. Transactions effected abroad – all Cashless Payment Transactions effected in any other currency than PLN. The limit for transactions effected in any other currency than PLN cannot be higher than Daily Limit for Cashless Transactions.
2. Daily limit for Cash Transactions – a determined by ING Bank and the Customer maximum daily amount of Cash Payment Transactions, inclusive of a daily limit for:
  - a. Withdrawals effected abroad – all Cash Payment Transactions effected in any other currency than PLN. The limit for withdrawals effected in any other currency than PLN cannot be higher than Daily Limit for Cash Transactions.

#### Charge Cards and Charge Cards with Deferred Payment

1. Daily Limit for Cashless Transactions – Unutilized Card Spending Limit
2. Daily Limit for Cash Transactions – a determined by ING Bank and the Customer maximum daily amount of Cash Payment Transactions

Options that may be selected by the Customer as regards Daily Limits for Cashless and Cash Transactions are presented in Table no. 2.
